

PROCEEDINGS OF GOVERNMENT OF KARNATAKA

Sub : Constitution of Monitoring Committees at Bruhath Bangalore Mahanagara Palike and other City Corporations level to monitor the working of 6th Economic Census 2012.
Read : Letter No.ಆಸಾಂಎ/23/ಖಕೈಶ/31/ಆ.ನ/2010-11 dated. 04.05.2011 of the Director, Directorate of Economics and Statistics.

PREAMBLE:

The Director, Directorate of Economic and Statistics, in his letter read above has stated that, the Government of India is conducting the Economic Census periodically since 1977. Already 5 Economic Census were conducted. Now the Government of India has decided to conduct the 6th Economic Census during 2012. The field work of this census will be conducted from-16.4.2012 to 15.5.2012 in the State. The main objective of this census is to capture the information on all House hold Enterprises/Own Account Enterprises run by workers within fixed premises or without fixed premises as well as other public and private establishments in rural and urban areas.

It has also been proposed in the letter read above that, since the establishments are concentrated in city areas, for easy and smooth conduct of Economic Census it is necessary to constitute a Monitoring Committee at Bruhath Bangalore Mahanagara Palike at State Level under the Chairmanship of the Commissioner, BBMP, Bangalore who will also be designated as Ex-officio BBMP Economic Census Commissioner and Monitoring Committee at Zonal levels under the Chairmanship of the Additional/Special/Joint Commissioner, BBMP Zone, Bangalore who will also be designated as Ex-officio Additional Zonal Economic Census Commissioner and Monitoring Committee, at City Corporations under the Chairmanship of the Commissioner, City Corporation who will also be designated as Ex-officio Additional District Economic Census Commissioner.

The said proposal has been examined. Hence, this order.

- 3) Issuing suitable guidance to master trainers and charge officers for imparting training to Enumerators/Supervisors..
- 4) To monitor the field work, collection of field in schedules and its transfer to District Statistical Officers.
- 5) To co-opt members from different fields if necessary.
