

## **PROCEEDINGS OF GOVERNMENT OF KARNATAKA**

**Sub :** Constitution of Monitoring Committees at District/Taluk level to monitor the working of 6<sup>th</sup> Economic Census 2012.  
**Read:** Letter No.ಆಸಾಂನಿ/23/ಖಕೈಶ/31/ಆ.ನ/2010-11 dated. 04.05.2011 of the Director, Directorate of Economics and Statistics.

### **PREAMBLE:**

The Director, Directorate of Economic and Statistics, in his letter read above has stated that, the Government of India is conducting the Economic Census periodically since 1977. Already 5 Economic Census were conducted. Now the Government of India has decided to conduct the 6<sup>th</sup> Economic Census during 2012. The field work of this census will be conducted from 16.4.2012 to 15.5.2012 in the State. The main objective of this census is to capture the information on all House hold Enterprises/Own Account Enterprises run by workers within fixed premises or without fixed premises as well as other public and private establishments in rural and urban areas.

It has also been proposed in the letter read above that, for easy and smooth conduct of Economic Census, it is necessary to constitute a Monitoring Committee at the District Level under the Chairmanship of the Deputy Commissioner, who will also be designated as Ex-Officio District Economic Census Commissioner and District level officers of different departments as Members and nominating District Statistical Officer as the Member Secretary and at Taluk level to constitute a monitoring Committee under the Chairmanship of the Tahsildar, and nominate Sirastedar, Taluk Office as the Member Secretary.

The said proposal has been examined. Hence, this order.

- 2) To make suitable arrangements to give wide publicity in different medias to create Economic Census awareness in the public.
- 3) Supervising the training programmes and field work at Supervisors/Enumerators level.
- 4) To make suitable arrangements for collection of field in schedules and its transfer to District Statistical Officer.

5) To co-opt members from different fields if necessary
