

PROCEEDINGS OF GOVERNMENT OF KARNATAKA

Sub: Constitution of State Level Steering Committee to monitor the work of 6th Economic Census 2012.

Read: Letter No.ಆಸಾಂನಿ/23/ಖಕೈಶ/31/ಆ.ಗ/2010-11 dated: 04.05.2011 of the Director, Directorate of Economic and Statistics.

PREAMBLE:

The Director, Directorate of Economic and Statistics, in his letter read above, has stated that the Government of India has been conducting the Economic Census periodically since 1977. Already 5 Economic Census have been conducted. Now the Government of India has decided to conduct the 6th Economic Census during 2012. The field work of this census will be conducted from 16.4.2012 to 15.5.2012 in the State. The main objective of this census is to capture the information on all House hold Enterprise/Own Account Enterprises run by workers within fixed premises or without fixed premises as well as other public and private establishments in rural and urban areas.

It has also been proposed in the letter read above that, for easy and smooth conduct of Economic Census, it is necessary to constitute a Steering Committee at the State Level under the Chairmanship of the Chief Secretary who will also be designated as Ex-Officio Chief Economic Census Commissioner and Principal Secretaries of the concerned departments as its Members and nominating the Director, Directorate of Economics and Statistics as Member Secretary.

The said proposal has been examined. Hence, this order.
